2025 Pension Indexation Award Announced

The Pension Indexation Award is a Public Sector Pension Plan (PSPP) design feature that provides inflation protection by annually adjusting your pension benefit amount when the funded status of the Plan is greater than 110%.

The PSPP's target Pension Indexation Award is equal to 100% of the change, yearover-year, in the Canada All-Items Consumer Price Index (CPI), which is 3.63% for 2025.

The April 2024 valuation reports the Plan's funded status was well above the 110% threshold; therefore, the full 3.63% will be awarded. Funded Status of the PSPP as at April 1, 2024:

124.2%

Pension Indexation Award effective January 1, 2025:

3.63%

The Pension Indexation Award will be applied January 1, 2025.

Please note, if you retired in 2024, your 2025 award will be pro-rated.

Secure, Self-Serve Online Access Coming in 2025!

Pensioners will soon have another option to access their information.

After completing a selfregistration process, pensioners will gain access to monthly deposit notices and annual tax slips. Self-registration instructions will come by mail in the next months.

If you do not want to use the online service, don't worry. Information will continue to be mailed out as it is now.

Information Change Forms Available

A Pensioner Information Change form is required to report changes to the Pension Office. For example:

- address change
- additional income tax
- bank information change

The Pensioner Information Change form can be found at www.peipspp.ca under the 'Forms' section.

If updating your banking information:

- the account must be in the name of the member,
- the account must be at a Canadian bank account, and
- you should keep your old account open until your first pension payment has been deposited into your new account. This will prevent a disruption in your pension payments.
